- 1. The list of candidates whose names are shortlisted, has been provisionally called for Document Verification (DV) and Interview based on the credentials furnished by them in the **Online** Application for the Posts mentioned in the advertisement.
  - If at any stage of the recruitment process including after recruitment or joining, it is detected that information provided by him/her is incorrect/incomplete/false or is not in conformity with the eligibility criteria as prescribed in the relevant Advertisement, or if it is found that he/she has concealed/distorted any material information, his/her candidature/appointment will be cancelled without assigning any reason thereof.
- 2. The shortlisting of candidates is provisional. Final selection is subject to meeting all the requirements as laid down in the Advertisement and verification of all the required documents and credentials as furnished by the applicants in their online application as well as the marks obtained by them in the CBRT and subsequent Interview.
- 3. The candidates have been shortlisted for Document Verification (DV) and Interview in the order of merit of CBRT/OMR examination marks as per category-wise vacancies in each discipline including PwBD.
- 4. Any request regarding change of date for this purpose shall not be entertained in any circumstances.
- 5. In case of tie at cut-off level, i.e., more than one candidate scoring same marks at cut-off level, preference in selection shall be given to the candidate who is senior most in age according to the Date of Birth.
