## **IMPORTANT INSTRUCTIONS**

- 1. The list of candidates whose names are shortlisted, has been provisionally called for Document Verification (DV) based on the credentials furnished by them in the ONLINE Application for the Posts mentioned in the advertisement. If at any stage of the recruitment process including after recruitment or joining, it is detected that information provided by him/her is incorrect/incomplete/false or is not in conformity with the eligibility criteria as prescribed in the relevant Advertisement, or if it is found that he/she has concealed/distorted any material information, his/her candidature/appointment will be cancelled without assigning any reason thereof.
- 2. The shortlisting of candidates is provisional. Final selection is subject to meeting all the requirements as laid down in the Advertisement and verification of all the required documents and credentials as furnished by the applicants in their ONLINE application.
- 3. The candidates have been shortlisted for Document Verification (DV) in the order of merit of OMR examination marks (obtained out of 100) as per category-wise vacancies in each discipline including PwBD.
- 4. In case two or more candidates in the same discipline and category secured equal marks in OMR examination, all those candidates who secured equal marks will be called for Document Verification.

- iv. Valid SC/ ST/ OBC along with updated NCL (B)/ issued by the appropriate authority/ EWS certificate, as applicable in the prescribed format (as applicable for appointment to posts under the Government of India.)
- v. **Disability Certificate in case of PwBD candidate** in prescribed GoI format from Competent Authority/ Medical Board.
- *vi.* In case of OBC (NCL)/ EWS certificate must not be older than 1(One) year from the date of Document Verification.
- vii. Valid **Age relaxation cum Domicile Certificate / Discharge Certificate**, etc., if applicable in the prescribed format issued by a competent authority.
