NOTICE FOR BHMS ADMISSION, SESSION 2017-18, 29TH BATCH

This is for information of all concerned that few seats are vacant after the admission process held from 9th -11th October 2017; the details of vacant seat are as follows.

UR – 05 OBC – 2 SC – 4 ST – 2

Therefore the following Waitlisted candidate(s) are required to report to Academic Section (1st Floor) of NIH, Kolkata on 25th October 2017 (Wednesday) between 9 AM to 11 AM for provisional admission.

1. The admission will be purely on the basis of available vacant seats.
2. The Classes for the 1st BHMS shall start from 23rd October 2017.
3. The Candidature of the provisionally shortlisted candidates is subjected to verification of eligibility, Medical Fitness, Documents/ Testimonials/ Information as submitted by him/her. During the process of provisional admission or even at any stage thereafter if the candidate is found to be not eligible for the course or found to have submitted false information or suppressed any information then his/her candidature / provisional admission will be cancelled and she/ he will be liable for legal action as per Law. The next candidate in order of Merit will be considered in her/his place.
4. The candidates are required to deposit prescribed admission fees (non-refundable) of Rs. 35, 450/- (Thirty Five Thousand Four Hundred Fifty) (excluding hostel rent) mentioned in the prospectus in the form of crossed Demand Draft drawn on any Nationalized Banks in favour of "Director, National Institute of Homoeopathy", payable at Kolkata on the date of admission.
5. If any candidate fails to deposit prescribed admission fees for the course on the date of admission and/or fails to submit requisite documents on the date of admission or fails to report within the notified date and time of admission or reports on wrong date or time for admission, then his/her candidature/ provisional admission will be cancelled. The next candidate in order of merit will be considered in her / his place.

7. NIH, Kolkata will not pay any allowance to any student for appearing for counseling or admission
8. Mere appearance in counseling or admission does not qualify admission.
9. At present Hostel Facility is not available; students are required to arrange for their boarding and lodging during their course at NIH, Kolkata at their own cost and convenience.
10. Authority reserves the right to, modify the provisional list in case any misprint at any time.
11. The decision of the Ministry of AYUSH, Govt. of India, in the matter of admission shall be final and binding upon the candidate(s) concerned.

In case of any legal proceedings pending before any Hon'ble Court(s) of India in connection with eligibility criteria, medical Fitness, counseling/ admission, etc. orders there form will be implemented accordingly.
