- i. Officers of Central Government, State Government, Statutory Organizations, Autonomous bodies, PSUs, University holding analogous posts on regular basis in the parent cadre or department.

- 2. Application in prescribed Format must be completed in all respects and has to be forwarded by the cadre controlling authority.
- **3.** Self-attested photocopies of all essential documents (educational qualification and Certificates in support of their eligibility i.e. Admit Cards, Marksheets, age proof, Caste Certificates etc. & experience Certificate) and APARs of the last five years through proper channel should reach within the stipulated time period.
- **4.** Upper age limit should not exceed fifty-six (56) years as on the closing date of receipt of application.
- 5. Crucial date for calculation of age, etc. shall be the last date for receipt of the completed application.
- **6.** All the Documents should be page numbered in a chronological order.
- 7. Incomplete applications or application received after the cut-off date shall be summarily rejected and no communication in this regard shall be entertained.
