Minutes of the Preparatory Meeting for NAAC Accreditation
held on 4th and 5th April 2018 at National Institute of Homoeopathy, Kolkata.

The meeting was Chaired by the Director In-Charge, National Institute of Homoeopathy, Kolkata.

The attendance statement of Faculty Members, Doctors, staff those who attended the meeting is enclosed to this minutes of the Meeting.

At the outset Director In-Charge discussed that Secretary to Govt. of India, Ministry of AYUSH had visited the Institute on 8th December 2017. Secretary discussed with the faculty Members regarding various activities being taken up by the Institute and expressed his desire that NIH should get NAAC Accreditation by 31st December 2018.

Afterwards the matter was placed before the Academic Council Meeting of the Institute to discuss the modality of NAAC Accreditation. Faculty Members suggested that one resource person who is having expertise and experience in the NAAC Accreditation process should be invited to held a preparatory Meeting; accordingly, it was decided to invite Dr. Munir Ahmed R. Professor, Govt. Homoeopathic Medical College, Bangalore and he was invited as subject expert and presided the Meeting on 4th and 5th April 2018.

On the 04-04-2018 Meeting Dr. Munir discussed on the following aspects of NAAC Accreditation Process.

1. Basics of NAAC
2. Vision and Mission of NIH
3. Core values
 - a. Contributing to Nation Development
 - b. Fostering global Competencies among students
 - c. Inculcating a value system among the students
 - d. Promoting the use of technology
 - e. Quest for excellence
4. Assessment and Accreditation of Higher Education Institutes (HEIs)
5. Quality indicator Framework
 - a. Curriculum aspect
 - b. Teaching-Learning and Evaluation
 - c. Research, Innovation and Extension
 - d. Infrastructure and Learning Resources
 - e. Students support and progression
 - f. Governance, Leadership and Management
 - g. Institutional Values and best practices.

Dr. Munir further discussed the regarding the self-evaluation process and subsequent preparation of a *Self-Study Report (SSR)* to be submitted to NAAC which involves the participation of all the stakeholders – management, faculty members, administrative staff, students, parents, employers, community and alumni. A threadbare discussion was taken up on the fee structure, grading system and time frames, etc. involved in the NAAC accreditation.



On the 2nd day of the meeting i.e. on 5th April 2018, Dr. Munir advised that in the first step to achieve the NAAC Accreditation by the Institute, the following two aspects should be taken care of

1. Redefining the Mission and vision of NIH

He discussed that the Institute needs to revisit its mission and vision statement as far as NAAC Accreditation is concerned. The vision and mission of the NIH should be clear enough; it should include health care, education and research aspect of Homoeopathy. NIH must aim its mission and vision towards nation building as well as global leadership in homoeopathy.

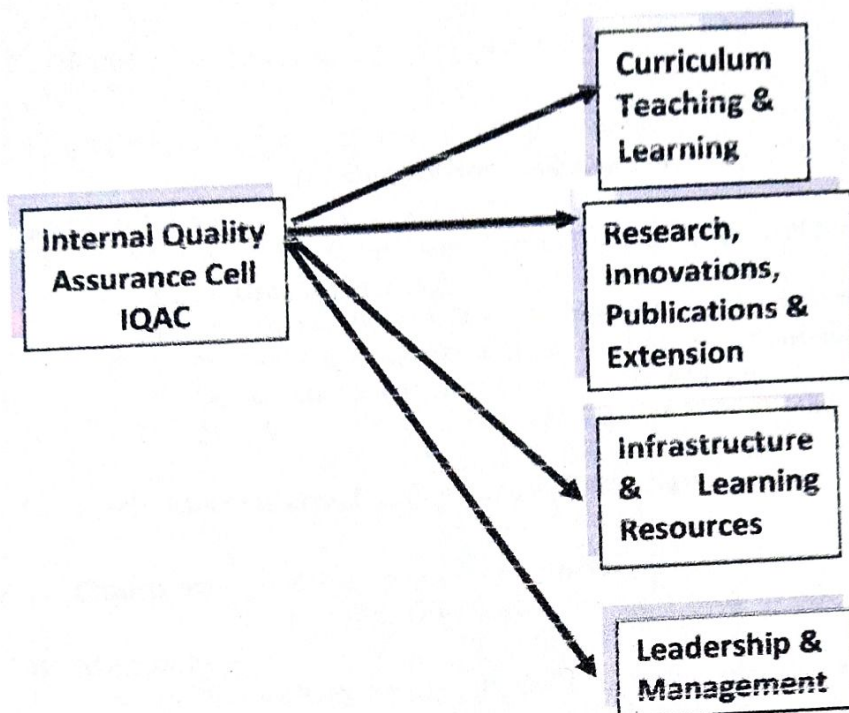
It is discussed that each faculty Member, doctor of the Institute should come forward with five vision statements for redefining the same. Faculty members suggested various vision statements, which were highly appreciated. After wards it was decided UG & PG students, faculty, doctors, staff of the Institute should be invited to give at least three vision statements. NIH authority may design a vision statement among that. Further NIH authority may also consider a cash prize of Rs. 5000/- (Rupees Five Thousand) for anyone who shall submit the best vision statement.

Guidelines for Preparing Vision Statement

- a. It should clearly speak about the mission and vision of the NIH in clear terms in national and global prospective
- b. it should include health care, education and research through Homoeopathy
- c. Prospective of NIH over the coming years viz. how and where NIH shall be in next year, in next five years and after 25 years from now.

That apart Dr. Munir emphasized, during the process of accreditation, question shall be framed from the vision and mission statement. Hence the clearer the vision and mission, easier to get the accreditation.

2. He informed that following five committees needs to be constituted by the NIH administration for the accreditation process. The hierarchy of the committees shall be as follows. The Internal Quality Assurance Cell (IQAC) shall be the apex committee and the remaining four committees shall function under its guidance.



Faculty Members doctors and other employees were requested to volunteer themselves to work under any single committee of their choice. Accordingly, faculty members, doctors, staff present in the meeting volunteered to constitute the following requisite committees. For those who are absent due to cogent reasons, their names were also included for constitution of Committees.
